



RE-CERTIFICATION COURSE FOR MINNESOTA COMMERCIAL VEHICLE INSPECTOR

Annual vehicle inspection laws are now in effect; your employees may become certified after attending this course to perform commercial vehicle inspections. Minnesota's program has been approved by the Federal Government so the State decal is valid as proof of inspection in all other states. The law covers: 1) Minnesota intrastate carriers who must have trucks 26,001 lbs. GVW inspected, and 2) interstate in Minnesota Statutes. Your employees may be certified as inspectors if: you are a motor carrier or leasing firm with trucks base plated in Minnesota, you are a licensed dealer who buys or sells commercial vehicles or, if your business is engaged in repairing or servicing commercial vehicles.

REGISTRATION FEES & TIME OF CLASS: Registration fee, \$75.00 per person (includes training and State of MN Certified Inspector fee). Fee includes seminar and all materials. Doors open at 7:30 a.m. Training begins promptly at 8:00 a.m. – **SORRY, NO LATE ARRIVALS WILL BE ADMITTED.**
